



Memorandum of Understanding between Overseas Education College, Xiamen University and Thaksin University

Party A: Overseas Education College of Xiamen University, China

Party B: Thaksin University, Thailand

In a desire to strengthen mutual contact and as a contribution to an increase in international cooperation, based on the principle of equality, voluntariness, honesty and mutual benefit, both parties have reached an agreement on following items regarding the study abroad programs after friendly consultations.

I. Summary

Party B shall send students to the International Chinese College of Party A to study for one year.

II. Responsibilities

- 1. Party B shall provide Party A the recommended lists 3 months before the semester starts. Party A will issue the materials required for the Visa application and provide related materials like admission to help the students to obtain the Visas timely as well as apply for the admission procedures smoothly.
- 2. The students' 3-year courses in Party B will be set up as Party B's undergraduate teaching program. During the students' one year study period in Party A,
 - Party B shall provide Party A with the compulsory courses and the elective courses. Party A will arrange the same or similar courses for the students of Party B according to the curriculum provided by Party B.
 - Meanwhile, Party A will convert the corresponding credits at Party B's request and provide Party B with the students' scores by the second week after the end of the semester.
- 3. The International Chinese College of Party A will assign specialized management staffs for the students.

III. Fees

During the students' study period in Party A,

- Party A will collect the tuition fee in accordance to the charging standards published by the school. If the number of students to be sent can reach 5 or more, Party A will collect the tuition fee in accordance to the charging standards provided by the agreement and offer a preferential price according to the number of students (the percentage for commission please find in the accessory).
- Within one month after the semester starts, Party B are supposed to pay the tuition fees of the students being sent to Party A.
- Expenses cost during the study period in Party A including accommodation expenses, traveling expenses, textbooks costs, transportation costs, certificate fees and Visa fees etc. shall be borne by the students.

IV. Effective duration, modification and termination of the contact:

1. The agreement is effective after signed and sealed by the legal representative or his/her proxy of both parties. The agreement is written in English, each with the same legal effect. The agreement is made into 2 copies, one for each party.

2. The contract can be modified or complemented in writing on base of negotiation and agreement by both parties. Supplemental agreements thus made shall have the same legal effect as the agreement. Should any problem occur in execution of the program agreement, based on the consensus of ensuring the legitimate rights and interests of the students, both parties shall settle the related problem by friendly consultation.

3. The contract is valid until June , 2019. Should Party A or Party B want to terminate the cooperation or modify the terms of the agreement, each party shall notify the other party in writing 3 months before the expiration of the agreement. If there is no objection, the agreement automatically extends for 3 years
